Nature of bill: Temporary duty suspension through December 31, 2011.

Formulations of caprolactones containing caprolactone-hydroxyethyl acrylate copolymer (CAS No. 110489-05-9) (provided for in subheading 3907.99.01).

Product information, including uses/applications and source(s) of imports:

The subject product is a caprolactone modified acrylic acid ester that is used to impart flexibility to acrylic polymers. This colorless to pale yellow liquid product is primarily used for UV cured adhesives for DVDs and other laminating applications. Japan is the country of origin for imports by the proponent.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. POLYCAPROLACTONE ACRYLATE.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:
