**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Cyano(3-phenoxyphenyl)methyl 2,2-dimethyl-3-(1,2,2,2-tetrabromoethyl)-cyclopropanecarboxylate (Tralomethrin) (CAS No. 66841-25-6) and application adjuvants (provided for in subheading 3808.91.25).

**Product information, including uses/applications and source(s) of imports:**

The subject synthetic organic chemical is a photo-stable pyrethroid class insecticide with highly potent contact and ingestion action that is effective against most flying and crawling insects. The product is imported from France.

## A BILL

To extend the temporary suspension of duty on Tralemethrin.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. TRALEMETHRIN.**

4       (a) IN GENERAL.—Heading 9902.24.35 of the Har-  
5       monized Tariff Schedule of the United States is amended  
6       by striking “12/31/2009” and inserting “12/31/2011”.

7       (b) EFFECTIVE DATE.—The amendment made by  
8       subsection (a) applies with respect to goods entered, or  
9       withdrawn from warehouse for consumption, on or after  
10      the 15th day after the date of the enactment of this Act.
