Technical comments:⁴

The Commission staff notes that HTS heading 9902.22.44 provides a temporary duty suspension for the subject product that expires on December 31, 2009. The Commission staff recommends that HTS heading 9902.22.44 be used to extend the existing duty suspension by modifying the effective date.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

To suspend temporarily the duty on sodium hypophosphite.

3 **SECTION 1. SODIUM HYPOPHOSPHITE.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:

8 (b) EFFECTIVE DATE.—The amendment made by
